WHAT IS A TEMPORARY BUYDOWN?

BUYDOWN MUST BE SELLER PAID

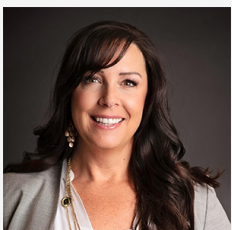
BENEFITS OF 3-2-1 BUYDOWN
